The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

- Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he falls to reply to such representations.

in terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. - INSTRUCTIONS TO BIDDERS WITH QUALIFYING REQUIREMENTS AND DOCUMENTS TO BE FURNISHED FOR THE CPMPREHENSIVE ANNUAL MAINTENANCE CONTRACT (CAMC) OF THE ONLINE UPS IN CBMR LUCKNOW.
- 1.1) The bidder should have been in business of UPS maintenance SERVICES of different makes and models for last five (5) years and documentary proof may be submitted. Bidders should have a registered/branch office in Lucknow.
- 1.2) Bidders should have their own well established UPS repairing centre, warehouse. The physical visit of the Service centre may be carried out by CBMR team if required.
- 1.3) The reference of at least 2 reputed clients/organization of state govt./central govt./PSU/autonomous bodies, other than CBMR, with whom the bidder has entered into the CAMC during the last 5 years should be furnished with the bid along with copies of satisfactory performance certificate and contract agreements.
- 1.4) The minimum average annual financial turnover of the bidder during the last three (3) years ending on 31st March of the previous financial year should be more than 20 lakh with documentary proof of ITR and annual accounts along with audit report if any.
- 1.5) Service tax/GST registration certificate.PAN card and MSME exemption certificate if any to be attached.
- 1.6) The bidder should not be blacklisted, bankrupt, under liquidation, court receivership or similar proceedings. Bidder to upload undertaking to this effect with bid.

2)- SCOPE OF COMPREHENSIVE AMC AND ITS IMPLEMENTATION

The service comprises preventive and corrective maintenance; repair to make all UPS operational also includes carrying preventive maintenance every quarter. If any other item/part, which is excluded from the offer of CAMC, must be quoted otherwise it will be assumed that all parts are included in CAMC.

2.1 The successful bidder is required to send technically qualified Engineers on call basis, which should have minimum two years of working experience in repair of UPS and carrying out preventive maintenance services.

The Engineers should attend the call within four hours and repair the UPS within 24 hours. If the same is not repairable within 24 hours then the company need to provide standby UPS.

The engineer(s) shall not carry out any maintenance repair work of any other party in CBMR premises.

- 2.2 The successful bidder also provides the regular preventive maintenance service minimum once in three months. Under this activity, following jobs are to be done:-
- ➤ Internal & External cleaning of the UPS (only which are under CAMC) using vacuum cleaner/other appropriate means.
- > Up-keeping of UPS to maintain satisfactory performance of the items connected through it.
- 2.3 Engineer will maintain a register for preventive maintenance. Engineer will also shift UPS as and when required at no extra cost.
- 2.4 The CAMC would be comprehensive in nature i.e. including maintenance of equipment & replacement of all new original spares in original packing for proper functioning of all UPS as per Annexe I installed at CBMR PREMISES.

If any part gives repeated problems i.e. 2 or more repairs in a period of two months' time, then the contractor/vendor must replace it immediately with an original new one without any additional cost on the part of CBMR.

It will also cover damage and burning of any part of the systems. All the components required to be replaced will be of original make (OEM).

- 2.5 The Contractor shall also submit a consolidated report furnishing the details of calls attended, remedial action taken and their status on a monthly basis.
- 2.6 The Contractor shall keep sufficient number of spares of UPS, as standby so as to put these in UPS whenever required and it can be repaired urgently. Any cost incurred towards transportation of the faulty/repaired as well as standby UPS shall be borne by the Contractor. The contractor shall not subcontract the maintenance job to outside agency.
- 3.0 Penalty:- the breakdown maintenance call shall have to be attended within two hours and UPS will have to be made functional within twenty four hours of the complaint, failing which the firm has to arrange for the alternative UPS with identical KVA till the original is repaired. In case the standby UPS is not provided or the original UPS is not set right to put the same under satisfactory operation within 48 hours, a penalty may be charged @0.25% of the contract value per day subject to a maximum of 10% of the CAMC charges of that UPS for the delayed period.

4.0 General terms and Conditions:-

4.1 Period of contract: The period of contract will be initially for THREE years from date of award and is liable to be terminated at any time by serving notice of ONE month by either party.

- 4.2 The firm will provide at least 04 (four) preventive maintenance in a year for all the UPS installed in the Centre.
- 4.3 The personnel/staff responsible for attending to the complaints should be stationed and available within the Lucknow.
- 4.4 Offer should be made in two-bid system i.e. Technical Bid and Price Bid. The Price Bid of those vendors who qualify under technical bid will be opened only.
- 4.5 The charges for CAMC of Online UPS as required should be quoted separately in Price Bid only.
- 4.6 The prices should be on F.O.R. CBMR basis inclusive of all levies and duties wherever applicable which should be indicated clearly. The rates of GST must be clearly indicated wherever chargeable.
- 4.7 EMD, Income Tax / GST Clearance Certificate and all other information required as per our tender documents, must be furnished with technical bid only.
- 4.8 The tender terms & conditions be clearly typed or legibly written giving the full name and address of the tenderer. The tenderer should quote in figures as well as in words the rates and amount tendered by him/them. Alteration, if any unless legibly attested by the tenderer, with their full signature, shall invalidate the tender. The tender should be signed by the tenderer himself/themselves.
- 4.9 The tenderer should take care that the rates and amounts are written in such a way that interpolation is not possible. No blank space should be left, which would otherwise make the tender liable for rejection.
- 4.10 The tenderer submitting his tender would be deemed to have considered and accepted all the terms and conditions. No Inquiries, verbal or written shall be entertained in respect of acceptance or rejection of the tender.
- 4.11 The Centre reserves the right to cancel/reject in full or any part of the tender which generally do not fulfill the conditions stipulated in the tender without assigning any reason.
- 4.12 Any action on the part of the tenderer to influence anybody of the Centre will make his tender liable to rejection.
- 4.13 The tenderer shall submit the offer with in original copy of the tender documents duly signed on each page. Item-wise rates indicating units can be offered on letter head of the firm.
- 4.14 Payments shall be released on QUARTERLY BASIS on satisfactory performance.
- 5.0 ARBITRTAION:- All disputes and question, if any arise between the Centre and the bidder out of or in connection with the terms and conditions contained herein or as to the construction of application thereof, or the respective rights and obligations of the parties there under or as to any clause or thing herein contained or by reason of the operation and maintenance or failure or as to any other matter in any way



relating to these presents shall be referred to the President of the Centre/Chief Secretary of the U.P. Govt. or his nominee. The decision of the sole arbitrator shall be final and binding upon both parties and subject to adjudication of Lucknow Court. Place for arbitration shall be at Lucknow (U.P.). Venue of such arbitration proceedings shall be the Centre. Arbitration and conciliation Act 1996 and rules made there under shall be applied to the proceedings under this clause.

6.0 PERFORMANCE SECURITY: - The successful bidder will have to submit a performance security equivalent to 5% of the contract value in the form of performance bank guarantee valid for 60 days beyond the end of the CAMC period along with the acceptance of the CAMC.

In case the performance security is not submitted by the successful bidder it will be presumed that the successful bidder is not fulfilling obligation of the contract.

In case the performance of the successful bidder is found unsatisfactory during the period of contract or if there is any breach of any of the terms and conditions of the contract due to fault the performance security will be forfeited and the contract for the the remaining period shall be deemed to be cancelled.

The performance security will be refunded to the contractor after the satisfactory completion of the CAMC period, on receipt of his/her claim along with pre-receipt, duly signed by the authorized signatory of the agency.

Performance securities remaining unclaimed for three years will be cancelled, automatically and no further claim will be entertained.

The contractor will ensure a proper service as per our requirement from time to time, against the agreement clause as per the terms & conditions agreed under negotiations would be provided at our Centre without fail. Any negligence on this account shall be the sole responsibility of contractor and the liability for compensation will be fixed up by the Centre of Biomedical Research, Lucknow.

Handing over after CAMC:-

The contractor shall provide services upto 10 working days after the date of expiry of the CAMC without any extra cost, so that all the equipment under maintenance may be handed over to the next contractor in a smooth manner.

If any UPS is not made available in working conditions on the last working day of the contract period shall be rectified/repaired by the contractor within next 10 working days, failing which the equipment shall be got rectified from alternative sources and cost thereof shall be deducted from the last quarter of CAMC payment.
